- ✓ transmission of commercial information, newsletters and personalized offers;
- ✓ insuring the archiving of the financial-accounting documents according to the tax regulations in the field;

The processed data is not transferred to the E.U. or outside the E.U.

The data is processed only in the period of time you benefit from our services and are archived for the period of time regulated by the law.

The recipients of this data can be, as appropriate: you as the targeted person, the legal entity and its agents (employees and/or contract partners), the local/central public authorities (Courts, I.T.M., A.N.A.F., ARBDD, ANR).

The lack of your consent to process the personal data previously mentioned, manifested by the refusal to provide us the access to this data, as detailed in the content of the work forms, determines the impossibility of providing or performing the services and activities assumed or legally designated as legal operator.

According to the Regulation (EU) 679/2016, you have right of access, rectification or deletion, of restricting the processing, the right of opposition and the individual decision process, the right of data portability, the right to withdraw your consent at any time, without any effect on the lawfulness of the processing based on the consent before its withdrawal, the right to complain before a surveillance authority, rights that are also detailed in the document attached to this notice. For exercising these rights, you can refer with a written, dated, signed and registered demand at the headquarters of the legal operator, mentioned in the introductions.

You are also granted the right to appeal to the courts.
